Below and on the reverse side you will find a schedule of accepted fines. If you wish to remit your fine by mail, please sign the Plea of Guilty or Nolo Contendre below and return this letter to my office together with your copy of the citation and money order or cashier's check **ONLY**. You can also pay Online at paya.com/paygov and in person. Otherwise, you will need to appear on the court date listed at the bottom of your citation. A plea of Nolo Contendre means you do not contest the charge or charges against you. The fine for a Nolo Contendre plea is the same as that for a plea of Guilty. Either plea indicates you agree to waive appearance before the Court for trial.

IF YOU FAIL TO RESPOND TO THE CHARGE OR CHARGES BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE OF \$626.00 PER CHARGE OR CHARGES MAY BE ASSESSED AGAINST YOU FOR VIOLATION OF PROMISE TO APPEAR AND WARRANTS ISSUED FOR YOUR ARREST.

IF A PERSON FAILS TO APPEAR IN COURT AS PROVIDED BY LAW FOR THE PROSECUTION OF THE OFFENSE OR IF THE PERSON FAILS TO PAY OR SATISFY A JUDGEMENT ORDERING THE PAYMENT OF A FINE AND COST IN THE MANNER ORDERED BY THE COURT. THE PERSON MAY BE DENIED RENEWAL OF THE PERSON-S DRIVER-S LICENSE.

You may also apply for **DEFERRED DISPOSITION** (which means that these charges will not go on your driving record) A Deferral Fee of \$100.00 is added to the fine and/or **DEFENSIVE DRIVING COURSE** by contacting the Court Clerk before the stated court date. Weekdays, Monday-Friday, between the hours of 8:00 AM to 3:00 PM and 3:30 to 5:00 PM at Bonham Police Department, 301 E. 5th Street, Bonham, TX 75418. (903) 583-2071.

THE JUDGE OF THE MUNICIPAL COURT WILL NOT HEAR ANY CASE EXCEPT ON THE SCHEDULED COURT APPEARANCE DATE.
